# The Summer Boating and RVing Season Is Winding Down

For some, we will be getting ready for the winter layup season. Up north, this was the time to start my boating wish list for the holiday season or what I would have the Marina work on when the boat was out of water. A little different here in Oklahoma. One of constants is that our boats, RV's, cars, homes and us are getting older. As boat and RV owners, we may not want to admit it or recognize it. And through innovation and technology, they can last much longer than they used to. But, like all of us humans, issues seem to occur and warrant attention, particularly as they get older. That continues to be mostly good news for those facilities that provide boat and RV maintenance servicing. But, even for those facilities there may come a point where the liabilities, often silent and lurking beneath the surface, outweigh the positives. The typical rough estimate is that there are about 12 million recreational registered boats and 13 million RV's in the United States in 2023. These are substantial numbers, and as time goes by, larger numbers of older boats and RV's are at the end of their useful life.

And here lays the safety concerns. There are those among us who are passionate about their old boats and RV's and have the time, talent and resources to keep them in great shape. But that does not apply to the majority. The cost to make repairs also start to make less sense, as does the ability to even be able to fix or restore things. Compounding the problem is the low cost of an old boat or RV and that may seem very attractive to a naïve buyer, who then does not have the ability to keep it going and fix what needs fixing. Metal and wood can decay and eventually fail. Abandoned boats and RV's are clearly a problem that has been on the upswing. For boaters, the worst fear is sinking. While most boaters are likely worried about sinking when they are on the vessel, the reality is that for every boat that sinks at sea, four will sink at the dock. Not that all these will be old boats, but older boats are at greater risk. An RV breaking down on a busy interstate has to be the worst thing for them. The costs for both are great. For older boats, the major reasons for hull failures typically center around thru-hullfittings and the composition or integrity of the hull itself. Many of these issues are easily discerned just by looking at the boats, preferably on dry land. Being garaged or in a covered slip protects the outside of the boat or RV, but everything inside is aging including engine, water and electrical systems which should be checked often.

The U.S. Coast Guard requires all commercial passenger-carrying vessels to be hauled approximately every two years, depending on different variables. The inspections are for leaks, hull soft spots and all the fittings. The inspections can be visual or more substantial. There are pollution issues that need to be checked from older engines that need to be checked. All the required safety items are aging such as life jackets, fire extinguishers, flares and ventilation blowers. Do not forget anchors, spare tires, jacks and tool kits. A working bilge pump is needed. It is not aging, but your insurance policy needs to checked and renewed. Not a safety item, but a required yearly item to be checked. Some companies are no longer insuring old boats or RV's. Proof of insurance is often required as part of a boat slip or space at the RV Park. Please check for any new exclusions. I hate getting older, but my yearly checkup is helping making it bearable.
