





Fellow squadron members,

Administrative Officer Mary Anne was truly the Master of Ceremonies for the evening, accepting responsibility for the wonderful dinner, her traditional Christmas poem, personal invocation and fun games. I, however, had the honour of presenting the Dave Bialorucki Excellence in Service Award to Dave & Mary Anne Kastl for their long-standing service & commitment to Vermilion, District7 and the United States Power Squadrons. Congratulations & Thank You, Dave & Mary Anne. Our food collection was a humbling surprise as we gathered 4 boxes, over 100 individual items of non-perishable foods, which Dave Bialorucki graciously delivered to the Lorain County Salvation Army. Celestially speaking; January is rather quiet. There is, however, our first Full Moon of 2025 on January 14th. the "Wolf Moon," where our indigenous people believed the wolves "howled at the moon" due to the harsh conditions of winter. And speaking of the moon, where we often discuss the Perigee & Apogee of the orbit of the moon, we seldom refer to the orbit of the earth around the sun, namely its Perihelion & Aphelion. The orbit of the earth around the sun is NOT a perfect circle, but an ellipse, therefore we have Perihelion, when the earth is closest to the sun, and Aphelion, when the earth is furthest from the sun. Perihelion will occur on January 4,2025 @ 8:28 AM, and Aphelion will occur July 3rd. These two cycles are relevant as they have an impact on our seasons, and their occurrences help us to understand the complexities of planetary motions. One interesting final note here, strangely enough, OUR seasons are primarily determined by the tilt of the earth's axis, and NOT by its proximity to the sun.







Pics from our December meeting are scattered about this newsletter. We had good friends, good food, and good times.




